At QPP, we offer accredited community development, peer navigation, and case management services to support people living with HIV. We also provide peer-led testing for HIV and other STIs. With 42 staff across Queensland, we're making a significant difference every day.

We're specifically looking for someone who **lives with HIV in regional Queensland** (outside of the Gold Coast, Scenic Rim, Logan, Ipswich, Lockyer Valley, Redlands, Brisbane, Moreton Bay, Noosa, Sunshine, or Gympie regions). Ideally, you'll have prior leadership or board experience and be an ordinary member of QPP already. Your expertise and lived experience will be key in guiding our organisation's future. QPP is an Incorporated Association in Queensland of which our membership is made up of people living with HIV, and associate members who are allies of our positive community.

This is a really important role, and we're asking for a commitment of at least **1-2 years**. You can choose to serve as a volunteer or be remunerated according to Health Consumer Queensland Remuneration Guidelines. Your contributions will directly help us deliver vital services, reduce new transmissions of HIV and other STIs, advocate for the rights of people living with HIV, and build a supportive and inclusive community.

Primary Purpose of Role

The Regional Representative is responsible for ensuring the interests of people living with HIV in regional Queensland are represented and addressed by the Board. Applicants must live outside the boundaries of the Gold Coast, Scenic Rim, Logan, Ipswich, Lockyer Valley, Redlands, Brisbane, Moreton Bay, Noosa, Sunshine Coast, and Gympie Shire Councils.

Governance	 Contribute to enacting delegated authority for QPPs governing documents including the Constitution and governance related policy and guidelines. Operate at all times in accordance with Governance Standards as set out by the Australian Charities and Not for Profit Commission (ACNC). Ensure that the organisation's financial affairs are conducted with transparency and accountability in an ethically, environmentally, and socially responsible fashion. Assist in monitoring the organisations performance and ensure it aligns with the collective interests of members, stakeholders, Board, management and employees. Enact legal duties as required: Act in good faith and for proper purpose. Act with reasonable care, skill and diligence. Do not improperly use information or position.

	 Disclose any conflicts of interest and where appropriate refrain from voting on related matters.
Leadership	 Contribute to organisational performance to deliver value and benefits to members and community with a particular focus on members living in regional or remote Queensland. Contribute to the collaborative development of the organisations vision, values and behaviours. Demonstrate, promote and monitor a collaborative and unified organisational culture. Contribute to Board, CEO and other key executive positions recruitment, induction, evaluation reviews, skills development and succession planning. Oversee the management of elevated financial critical incidents as required.
Strategic Direction	 Contribute to the development of the strategic direction and objectives of the organisation to ensure that the interests of regional and remote Queenslanders are identified and addressed. In conjunction with Finance Risk and Audit Committee develop budgets and allocation of resources that optimise delivery of the Annual Strategic, Operational and Communication Plans. Monitor the strategic direction of the organisation and the attainment of its strategies and objectives in conjunction with the executive.
Financial and Risk Management	 Participate in the Finance, Risk and Audit Committee, as required. Monitor the financial position and operational performance of the organisation including assessment of risk and audit function. Assure the principal risks faced by the organisation are identified, and ensure that appropriate control and monitoring systems are in place to manage the impact of these risks. Review and approve the organisation's internal compliance and control systems and codes of conduct. In collaboration with Finance Risk and Audit Committee ensure the timeliness and accuracy of the organisation's financial and other reports to the Board allow them to meet their statutory and constitutional obligations. Contribute to the design, implementation and periodic review of appropriate and effective policies, processes and codes for the organisation.
Strategic relationships and Communications	 Represent the public face of the organisation and views of the Board to its community and broader stakeholders, as required. Facilitate open and constructive communications amongst members and encourage their contribution to Board deliberations. Support the implementation of the communications Strategy targeting key political stakeholders and funding agencies, as required Promote the organisation to members, service partners and the community as opportunities arise. Support member and stakeholder engagement, reporting and information flows.



QPP Board Regional Representative Position Description

Board Members are required to obtain the following:

- National Police Check
- Blue Card
- ACNC Declaration that they are not bankrupt or disqualified from holding a governance role on a Board/committee.
- National Director ID number
- Required Vaccinations

Personal competencies for this position are:

- Lived experience of HIV and an engaged understanding of current health and legal policy as it relates to people living with HIV;
- Highly developed communication skills (both written and verbal) with the ability to effectively and confidently speak in public;
- Leadership skills including negotiation and conflict resolution.

Business competencies for this position are:

- Knowledge of corporate governance
- Financial management and reporting experience
- Business acumen
